

EXPANSION OF EADV TO INCLUDE NATIONAL SOCIETIES

1. General information

National societies may apply for membership since this is already possible under the current Statutes (see **Supporting membership** below).

The Society joins as a Supporting member. It pays 5 euro annually as a lump sum for each member on its books . **The individuals are not EADV members,**

Benefits

1. Annual meeting of EC and Board with Presidents of National Societies (Council of Presidents)
2. EADV News (Electronic version) sent to Society for distribution to its members
3. Society participation in EADV lobbying at European level
4. Society members can be appointed to EADV Task Forces
5. Reduction of **50** euro at Academic EADV meetings
6. Individual members of these societies may purchase an electronic version of JEADV for 25 euros. These are **purchasers of JEADV on line not individual members of EADV.**

NB-If however a society wishes to purchase JEADV on line in bulk for all its members, different conditions apply (see attached document re payments)

Mechanism

Before 15 January each year, each member Society sends a database of the members with a payment of 5 euros per person. Only those included at this time can avail themselves of benefits above. **This annual dues exercise is made only once yearly in January**

Eligibility

Any national society (not necessarily based in Europe) related to Dermatology and / or Venereology may apply

Application

Interested eligible organizations should apply to the Secretary-General who will bring the application to the attention of the Board of Directors for their decision.

NOTE- from Statutes

(E) Supporting members:

- (1) Supporting membership may be granted by the Board to **organizations*** which are particularly active in the field of Dermatology and/or Venereology.
- (2) Supporting members shall **not be entitled to vote and may not be elected to the Board or appointed Officers of the Academy.**

***(inter alia national derm ven societies)**

2. Payment details

Payment is **€5 per person declared** payable once annually before 15 January and a list of national society members eligible to agreed privileges should be attached.

If **JEADV on line** is also required, **an additional** payment of

€15 per person if ALL the persons on the list given are to take this option

OR

€25 per person if only some of the persons on the list above are to take this option.

Examples

Society A declares 100 members and JEADV is not requested by anyone

Payment is $100 \times 5 = \text{€}500$

Total = $\text{€}500$

Society B declares 100 members and requests JEADV for all of them

Payment is $100 \times 5 = \text{€}500 + 100 \times 15 = \text{€}1500$

Total = $\text{€}2000$

Society C declares 100 members and JEADV is requested by 10 only

Payment is $100 \times 5 = \text{€}500 + 10 \times 25 = \text{€}750$ Total = $\text{€}750$

NOTE- All payments are made once annually by the National Society and no changes are allowed until 12 months later. . The EADV office will supply bank account details and send an invoice if required.
